This product is a phosphate free formulation designed to provide effective cleaning, deodorization, and disinfection specifically for general household use, hospitals, nursing homes, schools, food processing plants, food service establishments, transportation terminals, automotive garages, office buildings, manufacturing facilities, lodging establishments, retail businesses, and athletic/recreational facilities where housekeeping is of prime importance in controlling the hazard of cross contamination. When used as directed, this product is formulated to disinfect hard non-porous inanimate environmental surfaces: floors, walls, metal surfaces, stainless steel surfaces, clazed porcelain, clazed ceramic file, plastic surfaces, bathrooms, shower stalls, bathtubs, variity toos, cabinets, tables, chairs and telephones.

This product deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, toilet bowls and any other areas which are prone to odors caused by microorganisms.
